WADSKIER, THEODORE VIGO (b. 1827). Generally associated with Chicago, where he established a practice in 1857, Theodore V. Wadskier was born on the Island of St. Croix and educated at the Royal Academy of Fine Arts, Copenhagen, Denmark. In 1850 he migrated to the United States and by 1851 appears in the Philadelphia city directories as an architect at 146 Walnut Street. One intriguing reference in the November 1, 1850, issue of the Public Ledger suggests that Wadskier was in Philadelphia by that date and in association with Samuel Sloan (q.v.) as joint proprietors of a Drawing Academy where they taught "everything conneted with Carpenters and Builders, Ornaments in Painting and Stucco, Stone and Wood Carvers..."

In 1852 he formed a brief partnership with Peter A. Nicholson (q.v.) with offices at 103 Walnut Street. The same year, Nicholson and Wadskier published The Practical sculptor, comprising a series of original designs for monuments, mantles, balustrades, & adapted to the present taste and style of architecture (Philadelphia, 1852).

According to the <u>Bulletin</u> of the Illinois Society of Architects, Wadskier moved to Chicago in 1857—his last Philadelphia directory listing is for 1856—"where he set up as an architect and prospered, designing and carrying out churches, business blocks and residences. The savings accumulated through the years were wiped out by the Chicago Fire of 1871, and Wadskier, undaunted, continued to practice in Chicago. At least one of his buildings still exists at 32 South Wells Street."

Late in his career, Wadskier was joined in Chicago by Philadelphia-born Henry P. Harned (1849-1934) who moved there in 1872. Harned succeeded to the practice when Wadskier retired.

WAGNER, ADAM C. (fl. 1882 - 1901). Adam C. Wagner appears in the Philadelphia city directories as either an architect or an engineer for the years 1883 to 1901. Breweries were his specialty.

WALKER, JOHN ARTHUR (1884 - 11/1/1938). English-born John A. Walker appears in the Philadelphia city directories from 1925 to 1930. From 1922 through 1927 he was associated with the firm of Walker & Carswell, with Harold Thorp Carswell (q.v.). Given Carswell's association with the firm of Cram, Goodhue & Ferguson, it is not surprising that Walker & Carswell continued that firm's work on Bryn Athyn Cathedral.

WALLACE, BRENTON GREENE (6/28/1891 - 6/1968). Born in Philadelphia, Brenton G. Wallace was the son of Richard H. and Lorena DeVoe (Groesbeck) Wallace. After graduation from William Penn Charter School in 1909, Wallace entered the University of Pennsylvania and gained his B.S. in Economics in 1913. In 1914 the firm of Wallace & Warner, with partner Frederick Warner (q.v.), was established and almost immediately successful in the type of residential development in the styles so popular at the time, particularly the Cotswold, the Norman Farmhouse, and the Pennsylvania Farmhouse types. Through 1961 Wallace and his partners expanded their building types; after World War II they specialized in commercial and industrial design: shopping centers, department stores, etc., including the Bryn Mawr Medical Building, Haverford Square Shopping Center, and the Wynnewood Shopping Center. Wallace was also a founder and first president of the Main Line Builders Association and influential in the development of both commercial and residential areas on the Main Line.

Active in both World Wars, Wallace received a number of citations for his military service and was the author of Patton and His Third Army (1946). He held memberships in the Union League and in the Merion Cricket Club.
